#### RECOMMENDATIONS FOR FILLING THE FORMS

- The Person Insured has the right to freely appoint or change, and he/she will have to fill this form on every new appointment. The insurance will be paid to the last beneficiary that is registered.
- If for different reasons the person paying tuition changes, the student should fill a new form and communicate this fact to the Institution so it can be reported to the insurance company.
- The names must be written as they appear in their official ID card.
- In case that you wish to appoint minors as beneficiaries, an adult must not be assigned as a representative of the minors for collecting compensation on behalf of their representation. The previous statement is because the civil legislations warn about the way tutors, executors, heir representatives, and other similar positions must be appointed, and they do not consider the insurance contract as the appropriate instrument for such designations.
- The designation of an adult as a representative of beneficiary minors, during their minority, could legally imply that the adult is appointed as beneficiary; who in any case would only have a moral obligation, but the designation done for beneficiaries in an insurance contract grants him/her the right to make use of the insured amount.
