

GENERAL EDUCATION AT CETYS UNIVERSITY

This is a work developed by the College of Social Sciences and the Office of the President. It was given to the internal Committee of WASC (CETYS) at a meeting in November 2010.

The following is a chronological account of documents in which the issue of GE was considered and explained and the comments made at the time, so it is suggested that the members of the WASC team with concerns in this regard review the text and annexes that allow them to have a more comprehensive and complete spectrum of the topic and, in that sense, can be more specific in the clarification and/or explanatory request.

December 2006 – Capacity Report

General Education:

1.-CETYS introduced courses of GE's engineering and business programs and explains that according to WASC's definition of GE, CETYS has a similar number of credits to the universities in the U.S: 35-40% of the total number of credits at the undergraduate level. CETYS offers some of GE's courses in the U.S at the high school level; Ralph said that they would have to make some adjustments in consideration to the format of GE from CETYS.

Comprehension of diversity – High School – Field 1

Civic Responsibility – High School – Field 1

Ability to work with others – For CETYS this is a didactic strategy – High School and Field 1
