 - 1. Revision and adaptation of the 2009 2011 curricular design proposal
 - 2. Revision of institutional and inter-institutional research projects and the corresponding calendars

 - 4. Organization of forums, conference cycles, and other academic activities tending to promote the study of Psychology as science
 - 5. Elaborate the Code of Conduct for the Academy of Psychology and Criminology
 - 6. Determine the periodicity of the meetings, which could be three during the semester.
