



**MEMORANDUM OF UNDERSTANDING ON COLLABORATION
BETWEEN
CALIFORNIA STATE UNIVERSITY, SAN BERNARDINO
AND
CETYS UNIVERSITY**

In recognition of the successful collaboration established among their campuses in an MOU signed in 1998 and an Addendum signed in 2000, California State University, San Bernardino (CSUSB) and CETYS University (CETYS) want to continue to promote academic cooperation and strengthen educational, cultural, and technological ties that will result in a better understanding between their institutions, support the internationalization of their campuses, and enhance their contributions to the well-being of their respective communities. To further these objectives, the institutions will use their best efforts to arrive at separate formal addenda in a broad range of areas to implement the following goals:

1. Both institutions will continue to develop collaboration between their colleges, departments, administrative staffs, and professors through such means as exchanges, sabbatical leave assignments, presentations, distinguished lecturers, collaborative research and publications, joint projects with business and industry, joint conferences and workshops, and professional development programs with all colleges and faculties. At CSUSB this would include all departments in the Colleges of Education, Natural Sciences, Arts and Letters, Social and Behavioral Sciences, and Business and Public Administration. At CETYS this would include the Colleges of Engineering, Social Sciences and Humanities and Business.
2. Areas of specific interest are dual degrees in Computer Science and Engineering, Business, Education, and the M.B.A. program, as well as special projects through graduate programs in Family Therapy.
3. Both institutions will attempt to exchange students through short-term academic programs and internships, especially in the academic departments listed above.
4. Both institutions will try to undertake joint activities with their students and appropriate units in artistic, cultural, and athletic areas.
5. Both institutions will promote institutional and academic cooperation through computing, telecommunications, and other modes of communication through information technology.

CSUSB and CETYS will encourage active contact between their respective colleges, academic and administrative units, and student groups to accomplish these goals.


This Memorandum of Understanding will be applicable for a period of five years effective at the signing of this document. It shall be automatically renewed for an additional five years unless either party expresses the desire to terminate the agreement. Either institution may suspend or terminate the agreement on a one-year advance written notice.


Each separate addendum to this Memorandum of Understanding will specify the objectives, manner of execution, financial obligations, term of validity, and administrative responsibility of each institution.
